The following entries represent a highly selective listing of recently added American imprints which have not found their way into the more commonly used bibliographies.

Ali Baba. *The Forty Thieves. And the overthrow of their protector, Orcobrand, the evil genius of the forest.* Philadelphia: William Charles, 1813. W. M'Culloch, printer. 12 engraved lvs., including wrappers. ¶ This edition is not recorded in Welch.

Armstrong, John. *The Pittsburgh Selection of Psalm Tunes: or ancient church music revived.* Pittsburgh: Cramer, Spear & Eichbaum, 1816. Robert Ferguson and Co., printers. [1], 111, [1] pp. ¶ Metcalf records a copy of this important tune book at the Library of Congress. Shaw & Shoemaker failed to note it.

Cohen, J. I., Jr. *Cohen's Lottery & Exchange Office, no. 110, Market-Street, Baltimore. Baltimore Hospital Lottery, second class, now*

drawing, ... Baltimore, [Aug], 1813. Baltimore: B. Edes. 2 lvs., 4to. Page [1] is printed in red; p. [3], dtd. in type Aug. 26, 1813, prints Wharton's, Nicklin's, and Cohen's list of the sixty-sixth day's drawing of the Medical College Lottery.

Craig, John H., 1787-1818. *The Confession of John H. Craig, who was...executed on Saturday, the sixth of June, 1818, near Old Chester, for the murder of Edward Hunter, Esq.* Philadelphia: J. W. C. Hanna, flying stationer. [n.d., 1818.] 12 p. 8vo. ¶ Unrecorded in McDade and Shaw & Shoemaker. Related to publications in McDade under number 223.

Duane, William, and Son, Washington, D.C. *Duane's Catalogue of Books & Stationery, for 1803-4.* Washington City: William Duane & Son, 1803. 39 p., 8vo.

The Girl I Left Behind Me. To which is added The Answer. Pretty Nancy. Return, O Julia. Yankee Doodle. January, 1811. [n.p.] 8 p., 8vo. ¶ An unrecorded songster which probably originated in the Philadelphia area.

Massachusetts. Laws, statutes, etc. *An Act, To prevent fraud in packing smoked alewives and herring, to regulate the size and the quality of the boxes, and the exportation thereof. ... (This Act passed Feb. 9th, 1808.)* [n.p., n.d.] Broadside, 4to.

New York (State). Court of Chancery. *Steam-Boat Navigation. Decrees of Chancellor Kent, of New-York; deciding the Navigation of New-Jersey, to the waters thereof.* [n.p., n.d. 1819?] ¶ This unrecorded pamphlet pertains to a legal case between Thomas Gibbons and Aaron Ogden over the incursion of the steamboat *Bellona*, commanded by Cornelius Vanderbilt, into the waters of the State of New York in May 1819.

Orange County, N.Y. Court of Common Pleas. *Rules, with Precedents of Costs, of the Court of Common Pleas of the County of Orange.* Goshen: James A. Chevee, 1819. 18 p., 8vo.

Pacificus, pseud. *The Apology of Pacificus, in reply to his calumniators* Philadelphia [n.d., 1808?]. 23 p., 8vo. ¶ One of three pamphlets bound up by William Darlington. The first is *A Serious Expostulation with the Society of Friends* (Philadelphia, 1808), Shaw & Shoemaker 15829. Authorship is attributed in a contemporary hand (Darlington's?) to John Peirce. The second pamphlet is *To Pacificus, in Reply to his essay, entitled "A Serious Expostulation ..."* by *Phila Veritatis* (Philadelphia, 1808), Shaw & Shoemaker 16316. Authorship of this pamphlet is attributed to Evan Lewis. Pacificus's *Apology* is unrecorded in Shaw & Shoemaker. The controversy revolves around the Federalist Pacificus's view that Quakers, in their Republican ardour, do not practice what they preach.

Sandwich Island Mission. *Constitution of the Original Hawaiian Church.* [n.p., n.d., Boston? 1819] 4 p., 8vo. ¶ This unrecorded pamphlet prints the Statement of Faith, signed in type, agreed to by the first members of the Congregational Church in the Sandwich Islands. Dated Oct. 15, 1819.

Wilde, Richard Henry, 1789-1847. *Substance of the Arguments delivered on the unconstitutionality of the Alleviating Act.* Augusta, Georgia: George Adams, 1814. 219, [3] p., 8vo.
