The third edition of *Political Works of Concealed Authorship Relating to the United States, 1789-1810* (Hamden, Conn.: The Shoe String Press, 1972), compiled by the writer, was released to the publisher early in 1971. Continued searching and a slightly broader scope have produced the 121 additions and the amendments set forth below. In major part the additions are from bibliographies, but 16 are from biographies, 14 from histories, and 16 from miscellaneous sources. Altogether 191 sources have produced attributions of authorship of 1056 anonymous or pseudonymous political works.
