Mr. Baron then offered the following resolution:

WHEREAS LOREN FRANK GHIGLIONE is one who, by his own admission, would happily have lived in the nineteenth century, that is, in a time lying on the most modern edge of the collecting scope of the American Antiquarian Society; and

Whereas LOREN FRANK GHIGLIONE possesses one of the most diverse and fascinating curricula vitae of anyone affiliated with this Society, a record representing deep accomplishment in the worlds of academia, commerce, and public service; and

Whereas LOREN FRANK GHIGLIONE was elected to membership in this ancient institution in April 1980 and, through the diversity of his interests and achievements, instantly straddled most of the strictly informal yet useful categories into which AAS members might be put—he is scholar, publisher, businessman, community leader, collector, and neighbor all in one and one in all; and

Whereas LOREN FRANK GHIGLIONE has been a leader within the halls of AAS, serving as member or chair of the Committee on Nominations and the Committee on Membership and, since 1993, as a member of the Council; and

Whereas LOREN FRANK GHIGLIONE is now stepping down from the Council after six fruitful years in the service of the Society; now therefore

BE IT RESOLVED that the Officers, Councillors, and Members of the American Antiquarian Society extend their deeply felt gratitude to Loren Frank Ghiglione for his firm support and wise counsel, wish him well in all he chooses to do; and upon the records of the Society let this Resolution be inscribed and to Loren Frank Ghiglione let these sentiments be made known.

RESOLVED this twenty-second day of October, nineteen hundred ninety-nine, the one hundred eighty-seventh year of the Society.

The resolution was accepted with spirited applause.

Mr. Baron then offered a further resolution:

WHEREAS MARY BREMER KELLEY has been among the most distinguished scholars to grace the rolls of the American Antiquarian Society since her election to membership eight years ago; and

Whereas MARY BREMER KELLEY'S leadership role in the AAS book history program has grown over the years through her co-leadership of a summer seminar and her delivery of one of the annual James Russell Wiggins Lectures; and

Whereas MARY BREMER KELLEY has, moreover, given fully and freely of her sound advice and wise counsel to our beloved Society through her service on the Presidential Search Committee and on the Council; and

Whereas MARY BREMER KELLEY now ends six years of valuable

and devoted service to the Council, not to rest but, rather, to assume, in a week's time, the presidency of the American Studies Association in addition to all her other, manifold professional duties; now therefore

BE IT RESOLVED that the Officers, Councillors, and Members of the American Antiquarian Society warmly commend and thank MARY BREMER KELLEY for her superior service to this ancient organization through her position on its governing board and as one of its intellectual leaders, wish her success and fulfillment during her year as elected leader of our kindred learned society; and congratulate themselves that her role in our scholarly affairs will not soon diminish; and upon the records of the Society let this Resolution be inscribed and to MARY KELLEY let these sentiments be made known.
