Whereas Ruth Bradlee Brooking and her always-supportive husband Edward Brooking made donations to establish the Isaiah Thomas Descendants Fund for Acquisitions and have invited other descendants to add gifts that will continue the good work of their exalted ancestor in collecting printed Americana for this library; and

Whereas the cheerful Ruth Bradlee Brooking and her suave and witty husband Edward Brooking have brought joy wherever the semiannual meetings of the Society have traveled and even provided a venue for dinner, complete with a variety of fine wines in the Napa Valley; and

Whereas Robert Hyde Smith, Jr., has shared his encyclopedic knowledge of people within the book world and the larger cultural community to bolster the work of AAS's Membership Committee, including his gentle encouragement to elect more members from that other city in Massachusetts; and
